Class B Preferred Shares of the Corporation

 - ♦ This investment is intended to be held for a minimum of 3 years and has a targeted distribution of up to 8.5% per annum payable quarterly
 - ♦ Redemption Features (starting after the first year):
 - ♦ If redeemed between months 12 24, the redemption fee is 4.5% of the original purchase price
 - ♦ If redeemed between months 24 36, the redemption fee is 3% of the original purchase price
 - ♦ After month 36, there is no redemption fee
